**SUBJECT:** Board Announces Results of NS98-2 Call for Bids

**Halifax, N.S.** - The Canada-Nova Scotia Offshore Petroleum Board today announced the results of the Call For Bids No. NS98-2 for new exploration licences in the Nova Scotia offshore area. Call For Bids NS98-2, issued in December of 1998, was for twenty parcels in the Nova Scotia Offshore Area. Bids were received for nineteen parcels. The Bids represent the expenditures which bidders commit to make in exploring the land parcels during the initial five year period of a nine year licence.

Subject to Ministerial veto, and the bidder satisfying the security deposit requirements specified in the Call for Bids, the Board will issue nineteen exploration licences respecting the land parcels.

It should be noted that, prior to the authorization of any petroleum related activities, the operator must demonstrate to the satisfaction of the Canada-Nova Scotia Offshore Petroleum Board that such activities can be conducted in a safe and environmentally sound manner.

The Canada-Nova Scotia Offshore Petroleum Board is the independent joint agency of the Governments of Canada and Nova Scotia responsible for the regulation of petroleum activities in the Nova Scotia Offshore Area. Its mandate includes safety of operations, protection of the environment, resource conservation, rights management and Canada-Nova Scotia benefits.
